AS PER RULE.**

CUSTODIAN CERTIFICATE / UNDERTAKING WILL NOT BE ACCEPTED.

1. Provisional allotment letter (on-line generated)
2. Admit Card of the Exam issued by NEET.
3. Result/ Rank letter issued by NEET
4. Class 10th Pass Certificate.
5. Class 10+2 Pass Certificate
6. Class 10+2 Mark Sheet
7. College Leaving Certificate / Transfer Certificate from the Institution last studied.
8. Conduct/Character Certificate from any Gazetted Employee, if the same is not mentioned in the CLC / TC.
9. Category Certificate (SC/ST/OBC/SEBC/EWS/PwD) from competent authority in the prescribed form provided in the NEET brochure. The validity of EWS and OBC certificates is **One Year from the date of issue**. PwD certificate must be from the approved institution as per the list in the NEET brochure will only be accepted.
10. Two nos. Passport size color photographs
11. Proof of identity (Aadhar/ PAN/ Driving License/ Passport)
12. Bond has been implemented vide Govt. of Odisha Health & Family Welfare Department Resolution No.19046 dated 21.08.2020. **Candidates are required to produce the Bond completed in all respects, signed by the Principal obligator (Candidate), Sureties and Witnesses at the time of Provisional Admission. Candidates are to prepare the bond is ₹21 Non judicial stamp paper.**

BOND BY THE CANDIDATE AT THE TIME OF TAKING ADMISSION INTO MBBS/BDS COURSE IN GOVERNMENT MEDICAL COLLEGES OF THE STATE OF ODISHA

KNOW ALL MEN BY THESE PRESENTS THAT WE,

FULL NAME OF THE CANDIDATE, son/daughter/wife of _____, aged about _____ years resident of _____ in the district _____, in the state of _____, at present admitted to _____ course in the _____ Medical College, _____. (herein after called the Principal Obliger) and

Shri/ Smt. **FULL NAME OF THE FATHER/MOTHER/SPOUSE,** son/daughter/wife of _____, aged about _____ years resident of _____ in the district _____, in the state of _____, at present employed as _____ in the office/Department of _____ and

Shri/ Smt. **FULL NAME OF THE FATHER/MOTHER/SPOUSE [OTHER THAN ABOVE],** son/daughter/wife of _____, aged about _____ years resident of _____ in the district _____, in the state of _____, at present employed as _____ in the office/Department of _____ (herein after called the Sureties) do here by jointly and severally bind ourselves and our respective heirs, executors and administrators and legal representative to pay the Governor of Odisha, his successors and assigns (hereinafter called "the Government") on demand, the amount equivalent to Rs. 25,00,000/- (Rupees twenty five lakh) only that the Government incurs on account of a candidate having been placed on MBBS/BDS Course till completion of the said course.

WHEREAS the above Principal Obligator is placed on admission into MBBS/BDS Course and admissible by the Government;

AND WHEREAS for better protection of the healthcare of the Government in the State, the Principal Obligor has agreed to execute this bond with such condition as hereunder written;

AND WHEREAS the said surety has agreed to execute this bond as surety for the discharge of the above burden of the amount equivalent to double the amount of stipend for three years of study by the Principal Obligor.

NOW, THE CONDITION OF THE ABOVE WRITTEN BOND is that in the event of successful learning and completion of MBBS/BDS Course and obtaining registration thereof the Principal Obligor **NAME OF THE CANDIDATE IN FULL** is to render two years of service in the State of Odisha. In case the Principal Obligor fails to comply due to any reason, the Principal Obligor is liable for refund of an amount equivalent to Rs. 25,00,000/- (Rupees twenty five lakh), to the Government of Odisha.

Appointment under the State Government after successful completion of MBBS/BDS Course shall mean and include regular appointment through OPSC or Adhoc appointment or Contractual appointment etc. Once an appointment (any one of the above type) is given, the candidate shall have to join within 30 days from the date of receipt of the appointment order failing which, he /she will be required to pay the amount as calculated above.

Further in the event of leaving the course due to any reason before the completion of MBBS/BDS Course, leading to lapse of a seat, the Principal Obligor is liable for refund of an amount of Rs. 10.00 lakhs (Rupees ten lakhs) to the Government of Odisha.

AND UPON in Principal Obligor, **NAME OF THE CANDIDATE IN FULL**, and **NAME OF THE SURETIES IN FULL** the surety(ies) as aforesaid making such refund, the above written obligation shall be void and of no effect. otherwise it shall be and remain in full force and virtue and it is agreed and declared by the Principal Obligor and the surety (ies) that in the event of default without prejudice to other remedies that the Government may adopt, the Government shall be entitled to recover the aforesaid amount from the Principal Obligor and the Sureties jointly and severally in the form of public demand under the Odisha Public Demand Recovery Act, 1962.

Save and except death, permanent disability or selection for higher study under no circumstances, the Principal Obligor can forgo the appointment and posting and if it so happens he shall be liable to refund the money amounting to the amount equivalent to Rs. 25,00,000/- (Rupees twenty five lakh) for three years of study.

PROVIDED that the liability of the surety hereunder shall not be impaired or discharged by reason of time being granted by the Government or by any forbearance, act or omission on the part of the Government or any person authorized by it (wherever with or without the consent or knowledge of the surety nor shall it be necessary for the Government to sue the said Principal Obligor before suing the above bounden surety on any of them for the amount due hereunder.

Provided further that, in case of selection for higher study this bond will be seized to be operative till the study is completed and will be deemed to be in force on the date of completion

of higher study and accordingly, all the above mentioned clauses will be in operation for all purposes.
