OFFICE ORDER

Terms & Conditions for Contractual candidates

Contractual Assistant Professors are entitled for remuneration as under

- The Contractual candidate shall draw the remuneration against the post in which they are posted in MCH at remuneration as may be notified by the Government from time to time.
- Any additional incentive as may be notified by the Government for the said post shall also be applicable.
- The engagement shall be purely on temporary and on year to year tenure basis and may be for maximum period of 04 years subject to satisfactory performance or till appointment of Doctors as Assistant Professor on regular basis through OPSC, whichever is earlier.
- Other terms and conditions will be guided as per clause no.9 of Health & F.W Department Resolution No.8967/H Dt.25-04-2022.

Terms & Conditions for In-service candidates

- The Regular in-service candidate shall be allowed to draw salary from the post against which they are posted in MCH.
- For in-service Assistant Professor, salary, pay Protection and other service conditions shall be governed as per provision of Health & Family Welfare Department letter No.6547/H Dt.4-3-2017.
- The terms & conditions relating to job responsibility and etc of assistant Professor on deputation basis will be guided as per clause no.9 of Health & F.W Department Resolution No.8967/H Dt.25-04-2022
- The engagement shall be purely on temporary and on year to year tenure basis and may be for a maximum period of 04 years subject to satisfactory performance or till appointment of Doctors as Assistant Professor on regular basis through OPSC, whichever is earlier.

The Contractual candidates are to sign an agreement to the above effect. Any additional incentive as may be notified by Government for these posts shall also be applicable. The selected candidates are requested to join immediately before the Dean & Principal after being relieved from their present place of posting.
